AGENDA EXCOM-2025-04: STATEMENT BY ICA-ASIA PACIFIC

4. Mr. Balasubramanian Ganpathy Iyer, Regional Director of ICA-AP, congratulated NEDAC for its significant role in promoting the sustainability of agricultural cooperatives across the Asia-Pacific region. He emphasized that agricultural cooperatives are central to ensuring food security and livelihood resilience, especially in both rural and urban communities. He further pointed out that the 2030 Agenda for Sustainable Development recognizes cooperatives as key drivers in achieving the SDGs, particularly in eradicating poverty, improving access to essential goods and services, and protecting the environment. Through their collective efforts, agricultural cooperatives foster inclusive economies, enhance livelihoods, and strengthen the resilience of communities, creating a more sustainable and equitable future for all. He further thanked NEDAC for organizing the event and proposed collaboration with NEDAC in ICA activities.





AGENDA EXCOM-2025-05: STATEMENT BY CENTRE ON INTEGRATED RURAL DEVELOPMENT FOR ASIA AND THE PACIFIC (CIRDAP)

- 5. Dr. P. Chandra Shekara, Director General of CIRDAP, extended his gratitude as a special invitee at the meeting. He emphasized that this year is particularly significant as we celebrate the collective efforts of co-operatives, especially with 2025 being the International Year of Co-operatives.
- 6. He highlighted that to elevate co-operatives to the next level, we need to focus on building the capacity of cooperative leaders, promoting cooperative principles through sensitization and training, preparing solid business plans, and integrating startups and technology into cooperative activities. Additionally, establishing strong backward and forward linkages, along with ensuring sustained policy support, will be critical in driving the long-term success of cooperatives.

AGENDA EXCOM-2025-06: RECONSTITUTION OF NEDAC

- 7. Col. Himanshu, Director of NEDAC, briefed on the reconstitution of NEDAC. He further elaborated that while the number of staff in the NEDAC Secretariat has increased, the salary and expenditure have decreased. The Committee approved reconstitution. The reconstituted NEDAC Secretariat is as under:

AGENDA EXCOM-2025-07: PRESENTATION OF STATEMENT OF ACCOUNTS

- 8. Col. Himanshu, Director of NEDAC, presented the audited statement of accounts, which was approved by the Executive Committee. Regarding the proposal to open a fixed deposit account in the bank, he presented two options as follows:
 - (a) **Option 1**: Open a fixed deposit account in Thailand, with an interest rate of 1.5%.
 - (b) **Option 2:** Open a fixed deposit account in India, with an interest rate of 5.6%.





- 9. Col. Himanshu, Director of NEDAC also pointed out that when taking over the account from the previous director, it was noticed that USD 18,000 was shown in the account books, while the amount had already been remitted. In this regard, an explanation has been sought from the previous director.
- 10. **<u>DIRECTION OF THE COMMITTEE</u>** The legality and feasibility of opening an account in India should be thoroughly assessed from a legal perspective. If it is found to be legally unfeasible, a fixed deposit account should be opened in Thailand to invest the unutilized funds.
